



DUI SCHOOL

The Family Support Center offers DUI school classes that comply with the State of Nevada and Sixth Judicial Justice Court requirements. The Center utilizes the Flex Modules: An Impaired Driving Series. The Flex Modules are an evidence-based curriculum that encourages responsible decision making and reduces recidivism by assisting participants in making positive changes to their impaired driving behavior.

- 8 hours of classroom time
- Highly interactive course taught by State certified DUI instructors.
- Teaching tools include lectures, class discussions, homework, and videos. A final written or oral examination directly related to driving under the influence of intoxicating liquor or controlled substances will be administered.
- Course fee is \$160, payable at time of enrollment and is non-refundable unless course is cancelled by The Family Support Center.

Participants must complete Session 1 before completing Session 2 and the sessions MUST be at least 1 week apart. Session 2 should be completed one week after completing Session 1, but no later than 90 days after. Participants must complete and submit any homework to receive credit. If a participant misses the second session or part of the first session, the participant will be subject to a \$29 re-enrollment fee and must join a future session to make up the session in order to receive a certificate of completion.
